## **Repository and Portal Report**

## Collections added to Portal

No collections were ingested or harvested during this period; we have suspended all ingests in preparation for migrating content to the new DC3 repository system.

## **Repository and Portal Development**

- Migration of repository data and digital assets in production is still ongoing. As of Monday November 15 we have migrated approximately 883,000 digital objects representing 6.5 million files and 30 TB
- Anticipated completion date for migration is late November.
- Work on updating ingest scripts and derivative-processing pipelines for the new system is ongoing; it is anticipated that we should be able to resume ingests in December.
